The positive feedback and measurable outcomes from this work have been truly inspiring, motivating us to keep pushing forward.

NMOST has also continued to its deep relationship with NMPED, providing technical assistance to ESSER III-funded programs for more than **35 program sites** throughout the State!

With our Youth Entrepreneurship mini-grants, and our Advancing Young Women in STEM Scholarships, NMOST continues to invest in New Mexico's OST programs and youth. By collaborating and connecting, NMOST has been granted the opportunity to further our mission in ways we couldn't have imagined just a few short years ago. These accomplishments are a testament to the innovative spirit that drives our work and our unwavering commitment to the youth we serve. As we look ahead, we are more committed than ever to our vision of a future where every child and youth in New Mexico has access to high-quality, affordable out-of-school time programs. What We Do:

The New Mexico Out-of-School Time Network (NMOST) is a nonprofit that supports collaboration of public and private organizations and community members seeking to improve access to and quality of out-of-school extended learning programs — before and afterschool, summer learning, and youth development.



The Network Expands Access for ALL Youth

NMOST works to create a sustainable structure of statewide, regional, and local partnerships to support the development and growth of statewide policies to secure resources needed to sustain new and existing school-based/school-linked OST programs. After more than 7 years of advocacy, the NM Public Education Department (PED) allocated \$20 million for

afterschool, summer learning, and tutoring in HB2 – the state budget bill. To announce this big win for OST in our state, NMOST's Executive Director collaborated with Lt Gov. Morales in an Op-Ed published in all major regional newspapers, celebrating the educational wins from the state's legislative session, including the new OST funding in the state budget.






Policy. By raising public awareness, NMOST encourages agencies and policymakers to consider policies that support high-quality OST in NM.

NMOST Advocacy



In 2023, we introduced *Policy Site Visits: Tips for Afterschool and Summer Learning Providers*. Our comprehensive 28-page advocacy tool kit equips program leaders with the knowledge and strategies needed to effectively advocate for expanded funding and resources. Through targeted tips and thorough templates, our advocacy toolkit empowers afterschool and summer learning providers to articulate the critical impact of their programs on youth development.





The Club Teen Center

The Club Teen Center in Santa Fe Place Mall operated by Boys & Girls Club of Santa Fe/Del Norte was a standout among the ESSER III-funded programs NMOST visited this year. This unique space provides a variety of opportunities for teens to explore their interests, connect with others, or just relax. There is a podcast studio that has been used to produce "ALL IN: United Voices," a podcast by Zia Keystone Club that "explores the history, progress, and social issues of

inclusivity, diversity, justice, and equity" and is available on

Spotify. The Club also provides access to video game consoles, a café with free snacks and meals, on-demand tutoring, and opportunities like VR job training. Youth lead the way at The Club; Keystone Club members set the rules, schedule, and activities. Impressively, the Keystone members have completed 600 hours of service!








\$41.500 in scholarships have been awarded to high school and collegeaged young women across NM since 2018.

The Network Advances Youth Entrepreneurship

NMOST works to advance Youth Entrepreneurship (YE) in out-of-school time (OST) programs in underresourced communities across New Mexico. This effort has:

- Provided mini-grants to help expand youth entrepreneurship in OST programs.
- Cultivated new partnerships and professional development opportunities with organizations including technical assistance from VentureLab and Young Entrepreneur Institute.
- Developed a new OST Story Map focused on entrepreneurship programs across New Mexico.

Kids Can Youth Entrepreneur Program

Kids Can Youth Entrepreneur Program, a project of the Community Action Agency of Southern New Mexico (CAASNM), utilized mini-grant funds from NMOST to offer an out-of-school-time experience for 304 youth, including 198 returning and 106 new students, through ongoing programming in Las Cruces, Hatch, Gadsden, Deming, and Alamogordo. The program included 19 summer camps and formed new partnerships while strengthening

existing ones. Highlights include afterschool programs in Hagerman and Las Cruces, with youth market events and a Jr. Vendors Program. Expansion plans aim to grow programming in Luna, Otero, Chavez, Hidalgo, Sierra, Grant, and Lincoln counties, and outreach efforts are ongoing to establish new program sites.
